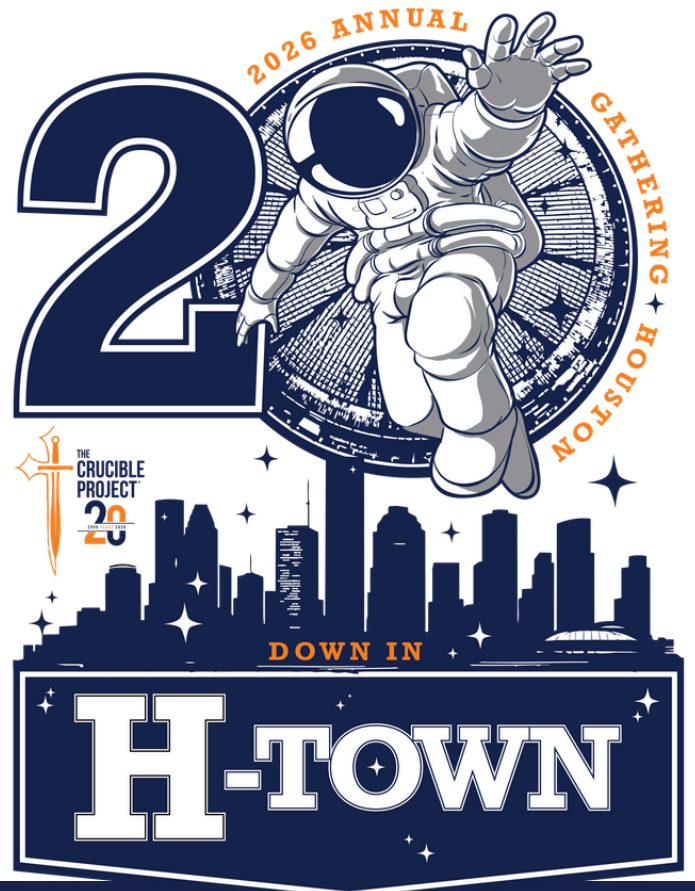

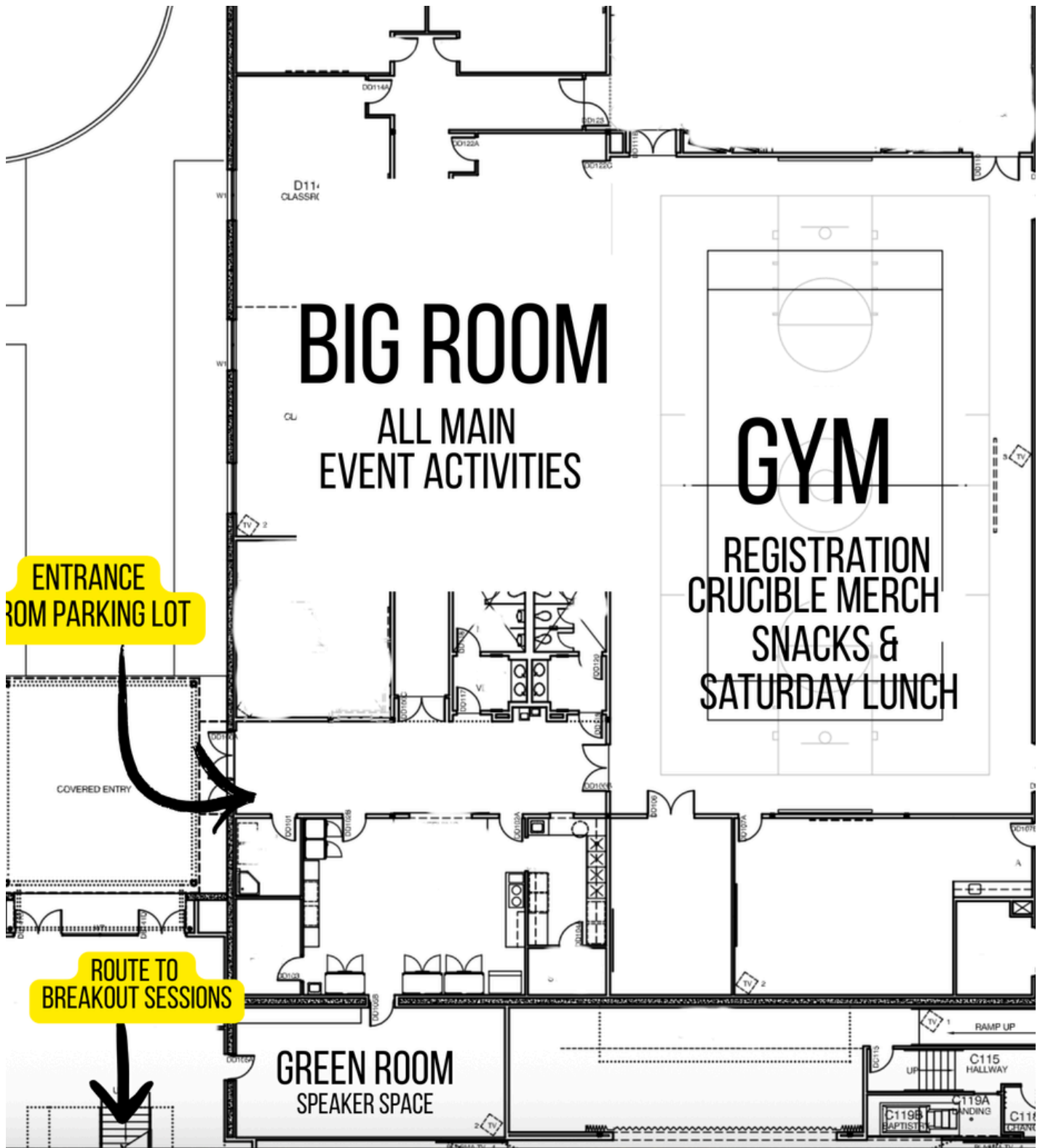

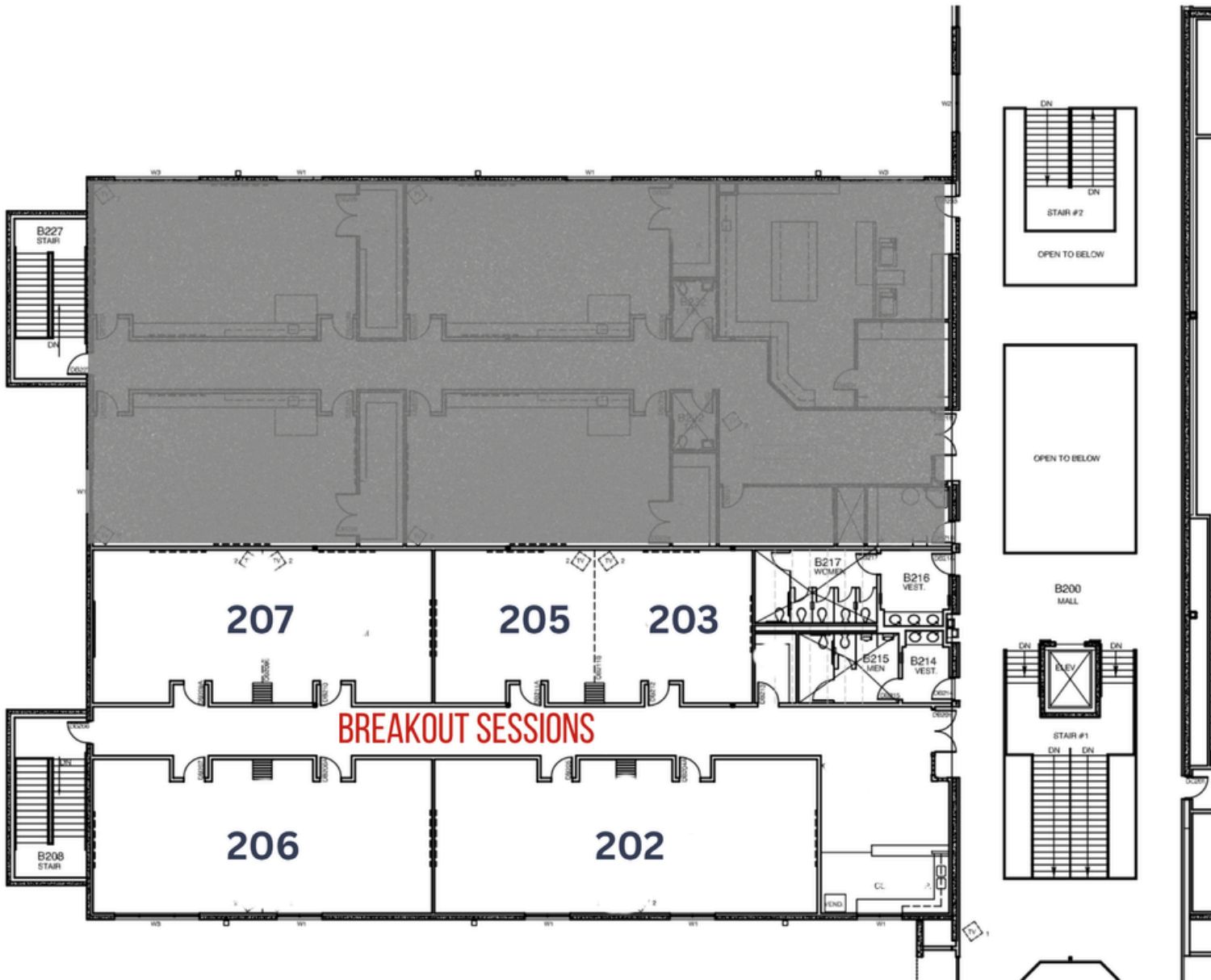

2025 Annual Meeting Minutes
July 26 2025
Denver, CO

Chair Linda Oury called the meeting to order.

Chair Linda Oury called for the approval of last year's minutes. Chris Cleghorn motioned to approve, Bill Snyder seconded. Minutes were approved unanimously.

Linda Oury recognized Executive Director Roy Wooten for the Executive Director's update. Roy reported end of year revenue was \$1.4 million, Equity was \$86,990. YTD net income was -\$10,000 excluding write-off adjustments. With write-offs the YTD net was -\$60,000. This year reported more donations than the previous year, other revenue was up 6%. The tipping point initiative and consulting fees were a big part of this. Records were broken with number of new Redwoods at 1,018, 48 Initial Weekends and 16 2nd level weekends. The draft Strategic Plan is being edited at this time. The final will be voted on in August. The focus is on Excellence, Financial Stability and Growth. \$2.51 million will be needed over 5 years to fulfill the strategic plan.

Linda thanked the staff and opened the meeting up for new business. There being none, Shawn Cole motioned to adjourn the meeting, John Ivan seconded. The meeting was adjourned.
